

Sweepstakes Official Rules

Quantity and Value of Prizes to be Given Away: **Ten** Winners of \$50 in Scratch-Off tickets for a total of \$500 in prizes.

3. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an "Entrant").
