

**Contest Official Rules**  
**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.**

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Contest.

Selection Date: On January 13, 2022

3. **ELIBILITY.** Open to legal residents of one of the eight counties of Western New York (Erie, Allegany, Cattaraugus, Chautauqua, Genesee, Niagara, Orleans, and Wyoming counties in New York State) who (i) are 21 years or older at time of entry, and (ii) will be fully vaccinated with one of the vaccines that have received emergency use authorization by the FDA for SARS-CoV-2 (the virus that leads to the illness known as COVID-19) by January 14, 2022 ("fully vaccinated" refers to the CDC's definition of "fully vaccinated" as of the launch of this Contest) (each eligible person to enter is an "Entrant"). Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
