

**HOLIDAY INN ROCHESTER DOWNTOWN
WEEKEND GETAWAY
ENTER TO WIN RULES**

NO PURCHASE NECESSARY TO ENTER, PLAY OR WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING.

ELIGIBILITY: The Holiday Inn Weekend Getaway contest (the “Contest”) is open to permanent legal residents of the United States (void in Puerto Rico, all U.S. territories and possessions and all overseas military installations). DISPUTES: The Contest Entities will make every reasonable effort to informally resolve any complaints, disputes, or disagreements that you may have with this Contest. If those efforts fail, by entering this Contest you agree that any complaint, dispute, or disagreement you may have against the Contest Entities, and any claim that Contest Entities may have against you, arising out of, relating to, or connected in any way with the Contest, a Prize, or these Official Rules shall be resolved exclusively by final and binding arbitration (“Arbitration”) administered by the America Arbitration Association.

We believe that Arbitration is a faster, more convenient and less expensive way to resolve any disputes or disagreements that you may have related to this Contest or your interactions with the Contest Entities. Therefore, pursuant to these Official Rules, if you have any dispute or disagreement with the Contest Entities or the website or service where this Contest appears, including any data or information you may provide to the Contest Entities or that the Contest Entities may gather in connection with such use, interaction or transaction, you will not have the right to pursue a claim in court, or have a jury decide the claim and you will not have the right to bring or participate in any class action or similar proceeding in court or in Arbitration.

The Arbitration shall use a single arbitrator and shall be held in Erie County, New York. The arbitrator shall apply the laws of the State of New York consistent with the Federal Arbitration Act and applicable statute of limitations. The arbitrator shall have authority to award any form of legal or equitable relief, provided, however, that in no event shall either party be entitled to damages in excess of actual damages or to recover punitive, exemplary, consequential, or incidental damages.

GENERAL RULES: By entering this Contest, entrants agree to be bound by these Official Rules (including but not limited to your consent to receive e-mail message from the Contest Entities), the terms and conditions of the Contest Entities’ websites, and by the decision of Contest Entities, which are final and binding in all respects.

The Contest Entities are not responsible for: (1) any incorrect or inaccurate information or technical failures of any kind; (2) unauthorized human intervention in any part of the entry process or the Contest; or (3) any other computer, network, technical, human or other error, problem or malfunction that may occur in connection with the administration of the Contest, the processing of Entries, or the selection or notification of Winners.
